Availability of the agenda was communicated in the advance notice. All proceedings hereafter shown were taken while the meeting was open to the public.

Mayor Ortiz led the discussion on approval of claims. No discussion was had. Council Member Dettmer moved to approve to pay the claims, Gigstad second. Roll Call: Yeas: Henke, Britton, Gigstad, Dettmer. Nays: none.

HEARING OF THOSE PRESENT – No one present.

SHERIFF REPORT – Deputy Holland present to report for the month of June. Total calls were 44 with three being noise nuisance calls all from fireworks, three vandalism/theft calls all were which gas drive offs, and seven traffic stops. The new system has been keeping Holland. Mayor Ortiz asked how the war on drugs is going; Holland said the county has seen a spike or increase in illegal use of prescription drugs. Germanfest was active for the deputies but nothing out of the ordinary.

FIRE REPORT – Bruce Neemann present. Neemann asked for approval to purchase four sets of bunker gear; these items are currently budgeted for. A coat and pants set will run around \$1600.00 – 1800.00 each. The older gear will be packaged and stored as back up in the event additional sets are needed. Council Member Britton moved to approve the purchase of four sets of bunker gear, Henke seconded. Roll Call: Yeas: Dettmer, Gigstad, Britton, Henke. Nays: none.

Mayor Ortiz led the discussion on approval of 2017-2018 SVFD Officers. Council Member Henke moved to approve the officers, Britton seconded. Roll Call: Yeas: Britton, Gigstad, Dettmer, Henke. Nays: none.

LIBRARY REPORT – Librarian Antes not present due to illness; the June report has been given to the Mayor and Council. No questions were had.

SWIMMING POOL & PROGRAMS AND PARKS REPORTS – Rec Coordinator Murrell presented both reports. Mayor Ortiz announced the City full-time employees were asked by the Syracuse Chamber of Commerce to be the Grand Marshalls of the Germanfest parade; seven employees were present at the parade.

Mayor Ortiz led the discussion on an additional batting cage for Sports Complex. Murrell presented bids from Baragary for \$8800 for concrete and Crouch Recreation for \$17,504.00. Murrell would like to place one structure consisting of two additional cages next to the existing cage at the Sports Complex. Mayor Ortiz explained he attended a VFW meeting the previous evening; Legion has offered to donate \$2000.00 toward the new batting cage with no stipulations. Murrell is checking into if turf is included in the Crouch bid so that the baseballs don't get so scuffed up. Alternative locations for the new structure

were discussed. The Council suggested Murrell receive an additional bid besides Crouch Recreation for the equipment portion. Discussion was had regarding unsupervised children and if a sign should be posted by the playground area. Clerk Farmer will check with LARM if language is available. Attorney Stilmock will provide the City with guidance on if the contractors working at the complex need to be bonded for performance and supplies. The discussion regarding bids is tabled until the August Council meeting.

Mayor Ortiz led the discussion on a bathhouse at the Aqua Center. Murrell and Pool Shift Manager Jamy Prokopec present. It had been discussed to have JEO help with the design. \$54,800.00 was budgeted in the current year; this was for design help from JEO. Burbach previously asked for \$19,000.00 using previous plans just updating. Prokopec explained numbers at the pool are up this year from previous years; Mayor Ortiz asked Prokopec to put together a comparison report. Pool concessions have profited roughly \$600.00 and the office person is working out very well. Britton expects to roughly estimate anywhere from \$320,000.00 and up for a new bathhouse. Having an account specifically designated for any fundraising money earned and donations was suggested, Clerk Farmer will speak with BMG regarding this or a "sinking fund". Money already ear-marked is the \$54,800.00 budgeted as well as the \$50,000.00 settlement with Waste Connections.

Mayor Ortiz led the discussion and approval of a water heater for the Aqua Center. The State Health Inspector recently paid a visit to the Aqua Center and explained the facility requires that swimmers shower before getting into the pool. Guards do not enforce this as the water is too cold. Bids presented were a 52-gallon from Sporhase at \$608.80 and Hemje is offering a 50-gallon unit for \$510.00. The Council suggested Shayna check into the existing water heater that is currently at the Aqua Center as well as if a larger size is available other than those presented in the bids and if they are gas or electric. The discussion will continue at a later meeting.

Prokopec also discussed adding mats for the bathhouse into the upcoming 2017-2018 budget at \$400.00 each as well as a handicap lift for the pool. This lift would be portable and would hold 375 pounds for the amount of \$5400.00. The Mayor and Council would like to see what other pools are using for handicap accessibility Prokopec also asked about a new PA system.

It was noted by Prokopec as well as Rescue Chief Wilson the Aqua Center staff handled a recent incident at the Aqua Center very well.

PUBLIC WORKS REPORT – Jeff Vogt present. Vogt opened his discussion by informing the Council the City's water main is not in the way of the bridge. Vogt will attend a hospital meeting on July 19<sup>th</sup> to discuss electric, water and sewer contractor expectations. The sign lighting for the Syracuse signs has been completed. A sign committee meeting has been scheduled to discuss the sign landscaping. Mayor Ortiz also discussed the question of the date on the signs; Dolphen Signs can accommodate a change in the year if necessary. Attorney Stilmock is pushing on completing the pioneering agreement with Loves hoping to have at the August Council meeting.

## OLD BUSINESS -

Mayor Ortiz led the discussion on Syracuse Streambank Stability Assessment. Attorney Stilmock has pushed out a couple ideas proposed by JEO.

Mayor Ortiz led the discussion and resolution authorizing advertisement for bids for equipment held in upstairs of City Hall building. Available are 49 movie theatre chairs, two gas stoves as well as a piano. Stilmock explained the bid would be per item, not for everything. The chairs are connected but Vogt will break up into groups of two or three. The discussion will be tabled until the September Council meeting.

Mayor Ortiz led the discussion and resolution regarding the Highway 50 Guardrail Agreement, authorizing Mayor's signature. The discussion will be tabled until the Special Budget Meeting scheduled for July 19<sup>th</sup> as there is a question on the donor amount. Mayor Ortiz will check with the donor to confirm.

## NEW BUSINESS -

Mayor Ortiz led the public hearing, discussion and Ordinance No. 1018 on Application for Entrance on Controlled Access Highway for 80 Park Street, Corey Hiller present. Attorney Stilmock explained the

Planning Commission previously met and recommended to move to Council for approval. Mayor Ortiz closed the public hearing. Council Member Gigstad moved to introduce Ordinance No. 1018 and move the statutory rule requiring reading on three different days be suspended, Dettmer seconded. Roll Call: Yeas: Britton, Henke, Dettmer, Gigstad. Nays: none. Attorney Stilmock read Ordinance No 1018 by title, Council Member Dettmer moved for final passage, Henke seconded. Roll Call: Yeas: Gigstad, Britton, Henke, Dettmer. Nays: none.

Mayor Ortiz led the discussion and approval for Otoe County-Wide Housing Rehab partial payment request and approval form for Project 15-OTF-02 in the amount of \$15, 859.00. Council Member Britton moved to approve the partial payment, Henke seconded. Roll Call: Yeas: Britton, Gigstad, Dettmer, Henke. Nays: none.

Mayor Ortiz led the discussion and resolution No. 17-26 on 2017-2018 LARM renewal, Mark Easter present. Easter explained the percentage decreases with the different options. There will be about a 6% increase in the premium from the 2016-2017 year. Easter went over the City's LARM payouts in the amount of \$63,192.00; Easter will send Clerk Farmer a list of losses. Easter explained other insurance carriers really look at the losses and payouts; LARM Board of Directors will review a claim if necessary. Council Member Gigstad moved to adopt Resolution No. 17-26 accepting a one-year term at a 2% discount with 180 day notice, Britton seconded. Roll Call: Yeas: Henke, Dettmer, Gigstad, Britton. Nays: none.

Mayor Ortiz led the discussion and Resolution No. 17-27 authorizing Mayor's signature on BMG's Engagement Letter for 2017-2018 budget prep services. Council Member Britton moved to adopt Resolution No. 17-27 authorizing Mayor's signature on the engagement letter, Dettmer seconded. Roll Call: Yeas: Gigstad, Henke, Dettmer, Britton. Nays: none.

Mayor Ortiz led the discussion on approval of Electricians and Plumbers for 2017-2018. Clerk Farmer provided a list of those who have turned in applications. Council Member Henke approved those on the list, Gigstad seconded. Roll Call: Yeas: Britton, Henke, Gigstad, Dettmer. Nays: none. A list of Plumbers and Electricians is kept current at City Hall.

Mayor Ortiz asked a Council Member to motion to adjourn. Council Member Dettmer moved to adjourn the meeting at 8:14 P.M., Henke seconded. Roll Call: Yeas: Gigstad, Britton Dettmer, Henke. Nays: none.
