December 9, 2015

The Mayor and City Council of the City of Syracuse, Nebraska met at 6:00 P.M. on December 9, 2015 for their regular meeting in the Syracuse City Hall Council Chambers at 495 5th Street. Present were Mayor Ortiz & Council members Henke, Gigstad, Dettmer and Britton. Notice of meeting was given by posting in three places. All proceedings hereafter shown were taken while the meeting was open to the public. Mayor Ortiz began the meeting by opening the discussion on the election and request for nominations for Council President. Mayor Ortiz opened the discussion on the appointments. SHERIFF REPORT – Deputy Holland present. There were 34 calls in November, 8 being Rescue calls. Holland explained problems with the tracking software regarding calls coming in thru the phone company coming into the system; the program is being updated currently. Low coverage hours are caused by vacationing and long-term disability affecting these coverage hours. Council member Britton inquired about a day-long speed monitoring, Holland said this is doable.

LIBRARY REPORT – Report presented by Sue Antes. Circulation and book clubs are running smoothly. Librarian Antes spoke of the Southeast Library group's monthly meeting regarding the position of the Nebraska libraries and administrative boards. Librarian Antes has communicated with

Senator Watermeier and read a letter she recently wrote to the Senator outlining Syracuse's stance. Turnout was good for the Library's Tannenbaum Santa visit and soup supper.

SWIMMING POOL AND PROGRAMS AND PARKS REPORT – Rec Coordinator Murrell has been working on the basketball schedule as well as the Tumbling schedule for January. Murrell has been speaking with JEO regarding a new bathhouse for the Aqua Center. Park Manager Aksamit has been working on winterizing all facilities as well as the soccer field equipment.

RESCUE SQUAD REPORT – Tim Wilson in attendance. Council Member Britton moved to approve Laramie Werner as a new member of the Syracuse Rescue Squad, Henke seconded. Roll Call: Yeas: Gigstad, Dettmer, Britton, Henke. Nays: none.

PUBLIC WORKS REPORT – Report presented by Superintendent of Public Works Jeff Vogt. Utility staff has been busy putting up the Christmas tree and decorations. Replacement of Christmas decorations was discussed. These are very expensive and will possibly need to be strung out over time. Sponsors and fundraising has also been mentioned.

OLD BUSINESS – Mayor Ortiz led the discussion on interest by Western Engineering Co. regarding leasing of City property. Traffic, smell, and future affects are concerns. Council Member Gigstad moved to decline the offer by Western, Dettmer seconded. Roll Call: Yeas: Henke, Britton, Gigstad, Dettmer. Nays: none. Mayor Ortiz led the discussion on request for change in speed limit on Hwy 50. Numerous letters have been written on behalf of the City. Attorney Stilmock will have the ordinance ready at the December meeting. Mayor Ortiz led the discussion on Municode. James Bonneville was available via phone to discuss questions. The legal review has been sent out by Roger Merriam of Municode. Syracuse has the option of linking to the Nebraska state codes by including the citation for that code in the City's code book. These are \$10 per link plus \$250.00 base rate, or the City can use only one link for a direct like to the Nebraska Legislature web page where an individual can search on their own. For the next two years, Municode will be reviewing changing state laws and how these affect Syracuse's code. Council Member Britton asked about linking to the state statute; Attorney Stilmock will follow up with Municode on this during the teleconference. Mayor Ortiz led the discussion on Nuisance Enforcement Program. Attorney Stilmock explained currently the City does not have a person that primarily takes care of this; Building and Zoning Inspector Bretthorst helps out but is typically an as-needed basis. Mayor Ortiz would like to continue this onto the January agenda as but more research is needed. Mayor Ortiz opened up the continued discussion on hiring another clerk for City Hall. This person would be more of community development position and would focus on special projects and programs such as a nuisance program and grants. The majority of the Council feel this would be a fulltime position. Job description and title will be researched.

NEW BUSINESS -

Mayor Ortiz opened the discussion and Resolution No. 15-19 authorizing the Mayor to sign documents regarding employment retirement plan sponsor change. Josh of Mutual of Omaha in attendance to explain. Council Member Britton moved to adopt Resolution No. 15-19, Dettmer seconded. Roll Call: Yeas: Henke, Britton, Gigstad, Dettmer. Nays: none. Mayor Ortiz led the discussion on the existing Treasurer's bond. Attorney Stilmock is working with Todd Blome of BMG on this. Mayor Ortiz led the discussion on a guardrail or fence for Highway 50. Ortiz will be having a meeting with SDA Schools Superintendent, Brad Buller regarding this. Mayor Ortiz opened the discussion on the end of probation and pay raise for Superintendent of Public Works, Jeff Vogt and City Clerk, Kelly Farmer. Council Member Britton moved to approve to end the probation and quarter hourly raise for both, Gigstad seconded. Roll Call: Yeas: Gigstad, Dettmer, Britton, Henke. Nays: none. Council member Dettmer moved to adjourn the meeting at 7:56 P.M.
