SHERIFF REPORT – Report presented by Chief Deputy Mike Holland. Deputy Holland stated that there were 71 calls in December, 26 being rescue calls. Chief Deputy Holland stated that the deputies are patrolling the Methodist Church debris and keeping all unauthorized individuals and children out. Chief Deputy Holland reported that there were no other major incidents during the month of December and first week of January.

PARKS & RECREATION REPORT – Report presented by Recreation Coordinator Ben Steele. Director Steele stated that two basketball teams will be participating in a tournament in Nebraska City and the top two teams of each age group with be participating in the League Tournament in Murdock.

Director Steele reported that the League Softball meeting will be held on February 12, 2014 at 6:30 P.M. at the Syracuse Public Library. The USSSA 12 & under Baseball Tournament will be held at the Sports Complex on April 26 & 27, 2014.

PUBLIC WORKS REPORT – Report presented by Superintendent of Public Works Garry Carman. City Attorney Stillmock opened the only bid received for purchase of used bucket truck. The bid was for used 2006 Chevrolet aerial truck from Altec NUECO of Birmingham, AL in the amount of \$47,600 delivered to Syracuse. Superintendent Carman stated that he has reviewed all documentation and has spoken with a representative of Altec and is in favor of purchasing the vehicle.

Council member Henke made the motion to approve the purchase of a used 2006 Chevrolet aerial truck from Altec NUECO of Birmingham, AL in the amount of \$47,600 delivered to Syracuse, second by Dettmer. Roll Call: Yeas: Henke, Lyon, Dettmer. Nays: None.

Mayor and Council reviewed with Evan Wickersham of JEO Consulting Group, Inc. the proposed One and Six Year Street Plan. Included in the one year plan is the 5th Street curb and

gutter repair. Included in the six year plan is alley replacement between Thorne and Plum Street, Old Highway 2 from Park and Oak Street and Midland Street Overlay.

Mayor and Council requested that the alley replacement between Thorne and Plum Street be included in the one year street plan. Mr. Wickersham will include alley replacement in the one year plan and get amended documents to the City Clerk. The hearing on the One and Six Year Street Plan will be held on February 12, 2014.

Discussion on cable television franchise fee and pole attachment agreement with Zito Midwest, LLC. was tabled until the February 12, 2014 meeting.

David Potter of JEO Consulting Group, Inc. appeared before Mayor and Council to review the 2011 Annexation Study.

Mr. Potter stated that municipalities annex properties to bring contiguous areas into the city limits, for growth beyond suburban development, extend utilities, equal the cost of providing city benefits and to extend the city's zoning jurisdiction.

All property to be annexed shall be urban and suburban in character and the City must have a plan in place to service the areas annexed.

Mr. Potter reviewed the annexation process with the Mayor, Council and resident attending the meeting. The steps are (1) prepare an annexation study, (2) hold public hearing with the Planning Commission, (3) recommendation of the Planning Commission, (4) public hearing held with City Council and the reading of annexation ordinances on three different days, (5) publication of ordinances and (6) notice to County.

Mr. Potter stated that to extend the City's zoning jurisdiction after annexation, the request goes back to the Planning Commission and then to the City Council.

Areas included in the 2011 Annexation Study are Area 2011-1 - N 1/2 NW 1/4 S15, T8, R11, Otoe County, Nebraska, except Meisinger Addition; except Meisinger 2nd Addition; except ZCI 1st Addition, Area 2011 – 2 - Tract 3-A, part of Lot 3, Dumke Subdivision, SE 1/4 NW 1/4, S15, T8, R11, Otoe County, Nebraska, Area 2011 – 3 - Tract 3-B1, part of Lot 3-B, Dumke Subdivision, SE 1/4 NW 1/4, S15, T8, R11, Otoe County, Nebraska and Area 2011- 4 - Tract 3-B2, part of Lot 3-B of Lot 3, Dumke Subdivision, SE 1/4 NW 1/4 S15, T8, R11, Otoe County, Nebraska.

Council member Lyon made the motion to adopt RESOLUTION 14-01: A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SYACUSE, OTOE COUNTY, NEBRASKA TO APPROVE, RATIFY AND ACCEPT THE 2011 ANNEXATION STUDY FOR THE CITY OF SYRACUSE, NEBRASKA, PREPARED BY JEO CONSULTING GROUP, INC.; TO APPROVE THE EXECUTION THREOF, second by Henke. Roll Call: Yeas: Lyon, Dettmer, Henke. Nays: None.

A true, correct and complete copy of said resolution is attached hereto and made a part hereof by reference.

Mayor Ortiz opened the public hearing to consider annexing the following-described real estate to be included within the boundaries of the City: 1. N 1/2 NW 1/4 S15, T8, R11, Otoe County, Nebraska, except Meisinger Addition; except Meisinger 2nd Addition; except ZCI 1st Addition, 2. Tract 3-A, part of Lot 3, Dumke Subdivision, SE 1/4 NW 1/4, S15, T8, R11, Otoe County, Nebraska; Tract 3-B1, part of Lot 3-B, Dumke Subdivision, SE 1/4 NW 1/4, S15, T8, R11, Otoe County, Nebraska; Tract 3-B2, part of Lot 3-B of Lot 3, Dumke Subdivision, SE 1/4 NW 1/4 S15, T8, R11, Otoe County, Nebraska, 3. Tract 9-B E 1280' NE 1/4, S9, T8, R11, Otoe County, Nebraska, 4. Tract 9-A E 1280' NE 1/4, S9, T8, R11, Otoe County, Nebraska and 5. Tract SE 1/4, S9, T8, R11, Otoe County, Nebraska, lying S of new Nebraska State Highway No. 2; except M. Pieloch Subdivision.

Mayor Ortiz invited the owners of property under consideration to be annexed to speak. Michael Angelo addressed Mayor and Council and stated that he feels that annexation is not necessary at this time as the City is not growing. Mr. Angelo stated that currently there are only a few new homes being built in the City. Mr. Angelo also stated that he feels that he is already paying his fair share of property tax.

Ron Zahn informed the Mayor and Council that if his property is annexed; it will raise his property taxes by \$1,100. Bobby Danner stated that he is against the annexation of his property due to his cost he would have incurred if he would have subdivided his property and given lots to his children.

Zachariah Tempelmeyer stated that he does not think that his property is contiguous and that his property is agricultural in nature. Mr. Tempelmyer stated that it would be cost prohibitive to develop his property.

Kent Antes stated that his property is the hub of his farming operation and also feel that the property is agricultural in nature. Mr. Antes voiced his concern on how he would be able to continue his operation as he has in the past, if he was annexed.

Lois Hansen was in attendance, but did not speak. Stanley and Kathy Stutheit did not attend meeting.

All property under consideration for annexation was included in the 2001 Annexation Study, 2005 Annexation Study or 2011 Annexation Study.

City Attorney Stilmock and David Potter explained to the property owners that the Future Land Use map shows that the City has been reviewing and planning on annexation of all areas surrounding the current City limits.

City Attorney Stilmock reviewed with Mayor, Council and property owners the recommendations of the Planning Commission.

Property 1 - N 1/2 NW 1/4 S15, T8, R11, Otoe County, Nebraska, except Meisinger Addition; except Meisinger 2nd Addition; except ZCI 1st Addition. The Planning Commission recommends annexation of property.

Property 2 - Tract 3-A, part of Lot 3, Dumke Subdivision, SE 1/4 NW 1/4, S15, T8, R11, Otoe County, Nebraska. The Planning Commission recommends annexation of property.

Property 3 - Tract 3-B1, part of Lot 3-B, Dumke Subdivision, SE 1/4 NW 1/4, S15, T8, R11, Otoe County, Nebraska. The Planning Commission recommends annexation of property.

Property 4 - Tract 3-B2, part of Lot 3-B of Lot 3, Dumke Subdivision, SE 1/4 NW 1/4 S15, T8, R11, Otoe County, Nebraska. The Planning Commission recommends annexation of property.

Property 5 - Tract 9-B E 1280' NE 1/4, S9, T8, R11, Otoe County, Nebraska. The Planning Commission does not recommend annexation of property.

City Attorney Stilmock read the ordinance by title upon its first reading and whereupon Council member Lyon moved that said ordinance be approved on its first reading and its title agreed to, second by Dettmer. Roll Call: Yeas: Lyon, Dettmer, Henke. Nays: None.

Whereupon, the Mayor declared Ordinance No. 942 approved on its first reading and its title agreed to.

Mayor Ortiz opened the public hearing on application for a conditional use permit pursuant to Syracuse Municipal Zoning Code Section 7.07.01 and 7.07.02 for erection of pole sign on the following described real estate: Lot A of the replat of Lot B, Block 1, Knolls Addition to the City of Syracuse, Otoe County, Nebraska.

Casey's General Store would like to place another 3'X4' sign on the existing pole sign. The conditional use has been approved by the Syracuse Planning Commission. City Building and Zoning Inspector Roy Bretthorst is in favor of granting the conditional use permit.

Mayor Ortiz closed the public hearing.

Council member Lyon introduced Ordinance No. 943 entitled: AN ORDINANCE OF THE CITY OF SYRACUSE, OTOE COUNTY, NEBRASKA GRANTING A CONDITIONAL USE PERMIT TO ADD CABINET TO EXISTING POLE SIGN ON THE FOLLOWING-DESCRIBED REAL ESTATE: LOT A OF THE REPLAT OF LOT B, BLOCK 1, KNOLLS ADDITION TO THE CITY OF SYRACUSE, OTOE COUNTY, NEBRASKA; TO PROVIDE FOR THE REPEAL OF CONFLICTING ORDINANCES OR SECTIONS; AND TO PROVIDE AN EFFECTIVE DATE and moved that the statutory rule requiring reading on three different days be suspended. The motion to suspend the rules was adopted by three-fourths of the City Council, and the statutory rule was declared suspended for consideration of said ordinance.

The Mayor then stated the question, "Shall Ordinance No. 943 be passed and adopted?" Upon roll call vote the following Council members voted YEA: Lyon, Dettmer, Henke. The passage and adoption of said ordinance, having been concurred in by a majority of all members of the City Council, the Mayor declared the ordinance adopted, and the Mayor in the presence of the City Council, signed and approved the ordinance, and the Clerk attested the passage and approval of the same and affixed her signature thereto.

Council member Henke made the motion to approve electrician license for Haco Electric, Inc., second by Lyon. Roll Call: Yeas: Henke, Lyon, Dettmer. Nays: None.

City Attorney Stilmock is continuing to work to update the City Codes and now has included the updating of the International Building and Electrical Code.

Council member Lyon made the motion to adjourn at 8:50 P.M., second by Henke. Roll Call: Yeas: Lyon, Dettmer, Henek. Nays: None.
