March 8, 2019

The Mayor and City Council of the City of Syracuse, Nebraska met at 4:00 P.M. on March 8, 2019 for a special meeting in the Syracuse City Hall Council Chambers at 495 5th Street. Notice of meeting was given by posting in three places. Council President Gigstad requested roll call, present were Council members Deb Dettmer, Orv Gigstad, Jerry Werner and Laramie Werner; Mayor Ortiz was absent.
