## November 18, 2020

The Mayor and City Council of the City of Syracuse, Nebraska met at the Syracuse Public Library located at 480 5th Street Syracuse, Nebraska at 6:00 P.M. on November 18, 2020 for a regular meeting. Notice of meeting was given by posting in five places. Council President Orv Gigstad sat in for Mayor Ortiz who was absent. Gigstad requested roll call; present were Council members Deb Dettmer, Orv Gigstad, Jerry Werner, Laramie Werner. A copy of the posting notice and acknowledgement of notice to the Council is attached to these minutes. Gigstad noted the Open Meetings Act was posted. Minutes for the November 4, 2020 special meeting were approved as written. Availability of the agenda was communicated in the advance notice. All proceedings hereafter shown were taken while the meeting was open to the public.

Gigstad led the discussion on Treasurer's Report and Approval of Claims; Todd Blome & Kylie of BMG present via telephone. The October Treasurer's Report has been distributed. Blome reported this report shows fiscal year end. Blome reported all bank accounts and transactions have been reconciled as well as bond payments. Ambulance income continues to fluctuate, Street expenses are up compared to this time last year, and overall Utility income has exceeded expenses thus far. Collectively, all other accounts outside of the Utilities show expenses have exceeded revenue. Blome has been working on gathering info requested by City Auditor Julie Bauman. Gigstad opened the Ambulance Report; Chief Tim Wilson present. Gigstad led the discussion on Physician Medical Director for SRS. Wilson explained the would like to switch their director to someone who has more experience with EMS; they have a physician in mind from University Med Center and would cost \$5000.00 annually. Stilmock explains the agreement reads five hours per month, is valid until June 30, 2022, and UNMC

provides insurance coverage. Wilson explained this is not a budgeted item. Caudill reported 70 calls for service for the month of October, 53 of those call generated incident reportsCaudill reported two search warrants, three arrests. Two separate instances of people driving on Syracuse soccer fields. Caudill reported the department has been working with Burlington Railroad Police Department. They will be in Syracuse and surrounding areas educating people on the increase traffic coming soon on the rail lines. The Sheriff's department will monitor the traffic over the tracks making sure people are stopping at the stop signs as people are not used to trains coming through town. The trains could be several hundred cars long. If lights or arms are to be installed that would be through OPPD Caudill explained, not necessarily by Burlington as OPPD owns the property where the tracks are.

Gigstad led the discussion and consideration of bids for new Gator. City Administrator Jessica Meyer and Tyler compared the presented bids from E.T.s Lawn & Leisure & John Deere, Collin recommended a bid from E.T. for a 2021 Ranger 1000 Crew at \$17,998.69. Gigstad opened the Public Works Report; Superintendent Jeff Vogt present. Orv led the discussions for Agenda Items 12 -A thru 12-C regarding Syracuse Utilities policies, noting the three items will be tabled until a future meeting.

Gigstad led the discussion and presentation on Managerial Water System Assessment; Ken Halvorsen of NE Rural Water present. Halvorsen supplied the Mayor and Council with copies of the assessment. This is needed because of the City's loans received from the DWSRF for the well field project. The assessment will be reviewed later on in the project to ensure the loan funds are being used the way they are intended to be. Council Member Werner and Attorney Stilmock commented on a couple of items that were incomplete or misspellings. Halvorsen will follow up on the questions, correct the document, and send Clerk Farmer a revised copy to distribute.

Gigstad led the discussion and Resolution No. 20-40 to approve Acquisition Contract and Warranty Deed with NDOT, authorizing Orv's signature. Attorney Stilmock explained this contract is regarding work being performed by NDOT to Highway 50 south of Syracuse. The land acquisition is for the land owned by the City for the well field. NDOT is appraising the land for \$630.00 for 1.3 acres of dry crop land. A form will need to be completed to notify the state who the tenant is. Council Member Deb Dettmer moved to accept Resolution No. 20-40 approving the contract with NDOT, Jerry Werner seconded. Roll Call: Yeas: Laramie Werner, Jerry Werner, Orv Gigstad, Deb Dettmer. Gigstad led the discussion and Resolution No. 20-41 on WWTP Aeration Upgrade Project, authorizing Orv's signature. Vogt explained in 2017 the project cost roughly \$25,000.00 now the project is estimated at \$32,740.00 to be completed by Kerns. The project consists of installing new piping. Proposed start date for the project is May 1, 2021. Council Member Jerry Werner moved to approve the bid from Kerns, Deb Dettmer seconded. Orv led the discussion and approval of iPad purchases for Utility Department. Jessica Meyer explained the iPads will enable Utility Employees to view maps, GIS mapping for electric, water and sewer lines, emails, as well as make notes while out in the field working. Currently they are trying to look at plans on large paper maps which is not easy in a truck. JEO helped guide us toward a device that would be compatible with the software used for the mapping and plans typically utilized. Council Member Deb Dettmer moved to approve the purchase of two iPads for the Utilities Department at \$879.00 each, Laramie Werner seconded. Orv led the discussion and Resolution No. 20-42 to approve final plans and specs for the water supply project to DHHS for a construction permit, authorizing Mayor's signature; Tim Adams and Dane Simonsen of JEO present. The two explained the final plans and specs have been distributed along with contingency plans. Council Member Jerry Werner moved to approve the construction permit, Laramie Werner seconded. Roll Call: Yeas: Orv Gigstad, Jerry Werner, Laramie Werner, Deb Dettmer. Nays: none.

Old Business – Orv led discussion and approval of 2021 Employee Health Coverage Plan. Jessica Meyer explained after hearing presentations from Inspro and Kohlmorgen Benefits, the employees have expressed concerns with staying with our current administrator and insurance therefore they prefer to go with the Medica plan through Inspro. Meyer also explained the issue with premium costs for dependent children and how a firm number needs to be decided on for what the City is going to cover for dependent children. Council Member Laramie Werner moved to approve going with Inspro and the City covering 85% of the premium for dependent children leaving the employee to cover the difference of 15%, Deb Dettmer seconded. Roll Call: Yeas: Jerry Werner, Deb Dettmer, Orv Gigstad, Laramie Werner. Nays: none.

Orv led the discussion and approval of 2021 Employee HRA Plan. Jessica Meyer explained this is something new the City has not participated in. This plan would take the place of the deductible reimbursements as an employee brings in an EOB. Jerry Werner noted the City could be opening itself up to having to contribute \$48,000.00 if everyone needed to use the HRA funds. Council Member Laramie Werner moved to approve \$1000.00 single, \$2000.00 family for City's HRA contribution to each employee annually, Jerry Werner seconded. Orv opened the continued public hearings and discussion for Item 13-C on ordinance to amend Figure 23 Future Land Use and Transportation Map of the Syracuse Comprehensive Plan as well as agenda Item 13-D to adopt a new Zoning Map. Stilmock explained he is still waiting on Jeff Ray of JEO to provide the City with correct maps and asked the two agenda items be continued until a future Council meeting to allow for the public hearings to remain open. Council Member Jerry Werner moved to continue the public hearings for the Future Land Use and Transportation Map and Zoning Map until the January 13, 2021 City Council meeting.

New Business – Orv opened the public hearing, discussion and Ordinance No. 1091 for Application for Conditional Use Permit for consideration of a second wall sign to Bay 5 at Runza located at Lot 6 Block 1 of Syracuse Business Center Syracuse, Otoe County, Nebraska; Wally of CBS Signs present. The permit asks for a second wall sign; the code allows one wall sign. Orv closed the public hearing noting publication had been had and a sign placed at the property; Planning Commission recommended approval by City Council for the second wall sign. Council Member Deb Dettmer moved to introduce Ordinance No. 1091 and move the statutory rule reading on three different days be suspended, Laramie Werner seconded. Roll Call: Yeas: Jerry Werner, Orv Gigstad, Deb Dettmer, Laramie Werner. Nays: none. Attorney Stilmock read Ordinance No. 1091 by title. Orv opened the public hearing to take action as described below on the following-described real estate: proposed Lot 1 Hansen 2<sup>nd</sup> Subdivision, a tract of land located in the South ½ of the Southeast ¼ of Section 9, Tract 8 North, Range 11 East of the 6<sup>th</sup> P.M., Otoe County, Nebraska; Mark Easter of Easter and Associates along with the Hansen Family present. Orv led the discussion and Ordinance No. 1092 to amend the Future Land Use and

Transportation Maps from Highway Commercial to Low Density Residential. This and the next item are for Change of Zoning for the property. Attorney Stilmock explained this is a two-step process. Orv closed the public hearing noting publication had been had and signage placed at the property; Planning Commission recommended approval by City Council. Council Member Laramie Werner introduced Ordinance No. 1092 and moved the statutory rule requiring reading on three different days be suspended, Jerry Werner seconded.
