The Mayor and City Council of the City of Syracuse, Nebraska met at Syracuse Public Library located at 480 5th Street Syracuse, Nebraska at 6:00 P.M. on January 12, 2022 for their regular meeting. Notice of meeting was given by posting in five places. Mayor Dettmer requested roll call; present were Mayor Dettmer and Council members Wesley Halvorsen, Laramie Werner, Jerry Werner, Orv Gigstad. A copy of the posting notice and acknowledgement of notice to the Council is attached to these minutes. Minutes for the December 20, 2021 regular meeting were approved as written. Availability of the agenda was communicated in the advance notice. All proceedings hereafter shown were taken while the meeting was open to the public.

Mayor Dettmer led the discussion and action on ordinance to utilize Public Safety Bond to finance purchase of new fire truck and or construct a new fire/rescue building; Jay Spearman of Piper Sandler present. Spearman discussed three options to be able to build a new fire/rescue house. The first being with a Public Safety Bond, option two would be to go through a Municipal Facility Corp which is subject to the City's lid, and the third option would be using fa municipal building bond capped at two million dollars. The third option requires leasing at least 50% of the building to another entity; the third option is exempt from the lid. Todd Blome of BMG was present and discussed the amortization schedule options. It was mentioned how the Rescue Squad utilized fundraiser funds when they purchased a new rig. The City recently purchased the land for the fire/rescue building for \$200,000.00; discussion was had on reimbursing the Main Operating Account and General Department. The fire department's budget includes \$50,000.00 for a land purchase. The Rescue fund can contribute the \$200,000.00 if necessary to reimburse the main operating account for the land purchase; the Rescue Fund would be reimbursed at a later date. Spearman discussed amortization schedule for options towards a new fire truck. Blome suggested the shorter the schedule the better. Blome mentioned borrowing a less amount and use cash reserves for portion. The fire truck has not been bid out yet; Spearman does not want the City to issue more bonds than necessary. Approval to move forward for bids for a new fire truck will be discussed possibly at the next Council meeting. The Council suggested tabling the ordinance until bids come in for the fire truck; Spearman explained the award of the truck bid and the approval of the ordinance could be done at the same meeting. Jay Spearman will wait to hear from the City after bids have been received.

Mayor Dettmer led the discussion and Resolution No. 22-01 to declare intent to incur indebtedness to acquire land for and construct a fire and rescue station and related public safety improvements and acquire related public safety equipment, authorizing Mayor's signature. Council Member Jerry Werner moved to approve adopting Resolution No. 22-01 up to \$500,000.00, Laramie Werner seconded. Roll Call: Yeas: Wesley Halvorsen, Orv Gigstad, Jerry Werner, Laramie Werner. Nays: none.

Mayor Dettmer led the discussion and approval of funding option for land purchase to reimburse City General Operating account. Council Member Orv Gigstad moved approve reimbursement of the General Operating account by using \$50,000.00 from Fire Savings, which was budgeted, \$50,000.00 from Cemetery General, which was budgeted for cemetery land purchase, and \$100,000.00 from Rescue Savings, which is reimbursable; Wesley Halvorsen seconded. Mayor Dettmer led the approval of claims and Treasurer's Reports, Todd Blome of BMG present. Blome clarified the reimbursements for Resolution No. 22-01 and what is funds versus cash. Blome reported a grant from Game and Parks for \$283,000.00 was received for the Aqua Center Bathhouse construction; ambulance income is up. Regarding expenditures, many capital outlay payments to JEO and Van Kirk Bros. related to the well field project. Clerk Farmer explained to Blome Van Kirk will also be providing services for the gravity sewer project. Year to date revenues are down a bit for utilities but Blome explained it may be a timing issue; Clerk Farmer will check on the cash rent payment due for the well field ground. Blome explained the City has a lot of projects going on and a lot of cash being paid out and to pay attention to the City's cash reserves. SHERIFF REPORT – Sheriff Caudill present. Caudill reported details from the December Incident Report distributed prior to the meeting. There were 62 calls for service, 45 were reportable incidents. Caudill discussed a crash by Love's Truck Stop. Caudill is suggesting reflective paint be used in this area to illustrate the turn lanes better. Nebraska Department of Transportation explained a study needs to be done in order for something like this to happen.

FIRE REPORT – Fire Interim Chief Keith McWilliams present, Mayor Dettmer led the discussion and approval of one member to the SVFD. McWilliams explained Liza Godsey of Otoe has been a dispatcher therefore she is familiar with emergency situations from the dispatch side. LIBRARY REPORT – Librarian Sue Antes not present; her report was distributed prior to the meeting. No further discussion was had.

BUILDING & ZONING REPORT – Inspector Bruce Neemann present. Mayor Dettmer led the discussion and action Ordinance No. 1117 on Vacant Property Registration Act; City Administrator Jessica Meyer and City Attorney Jerry Stilmock explained. The ordinance does cover residential and commercial properties. Stilmock explained vacancy requirements, a registration fee of \$250.00 annually for residential or \$1000.00 for commercial, and evidence of vacancy is defined in the ordinance. The ordinance also reads exemptions to show if a property is vacant. Refundable registration fees shall be considered. Council Member Orv Gigstad moved to introduce Ordinance No. 1117 and move the statutory rule requiring reading on three different days be suspended, Jerry Werner seconded. Stilmock explained because of Nebraska statute, the City has the ability to give notice to property owners regarding dead or diseased trees in the right-of-way. PARKS AND REC REPORT – Parks and Rec Director Jill Crook present. Mayor Dettmer led the discussion and approval to purchase water fountain for dog park explained. Three bids were presented; this item is in the Parks budget. Crook explained currently there is not a water line going out to the dog park; the utilities department would help run a line when the time comes. Crook is suggesting the freestanding fountain with the bottle filler, two hydrants and low one for the pet. The question of winterization was asked. Crook is not aware if this would need to be winterized; Superintendent Jeff Vogt not sure. She will reach out to the vendors to inquire; the item was tabled to allow for further research.

PUBLIC WORKS – Superintendent Jeff Vogt present. Mayor Dettmer led the discussion and Resolution No. 22-02 on 2022 Maintenance Agreement No. 45 Renewal and Certificate of Compliance between Nebraska Department of Transportation and City, authorizing Mayor's signature; Jerry Stilmock explain. This is an annual renewal. Council Member Orv Gigstad moved to adopt Resolution No. 22-02, Laramie Werner seconded. Roll Call: Yeas: Wesley Halvorsen, Jerry Werner, Laramie Werner, Orv Gigstad. Neemann explained the setback is 10° from back yard and 8° from the side yard; Cramer is asking for setback of 8° from the back yard. The concern of moving the rear yard setback to 8° is such his accessory building he wants to construct could be over the power line; therefore, Vogt would prefer the 10° setback be used. The public hearing was continued to February 9th, 2022 at 6:00 P.M. to allow for Cramer to attend and present his case.
