Mayor Dettmer led the discussion and approval of 2021 City Financial Audit; Auditor Julie Baumann present. Baumann explained the audit process; Todd Blome of BMG also present. This year an additional category was added due to the City requiring a single audit due to the Water Improvement Project and City accepting Federal money. Governmental activities include departments except for the utility departments, these are known as Enterprise activities. Governmental activities are on a cash basis and Enterprise utilize an accrual basis. Governmental shows an increase in assets, total equity went down a little or flat-lined and revenue went down. Baumann explained Governmental can change on a daily basis, the numbers shown in the 2021 audit are as of September 31, 2021. Baumann suggested the City be cognizant of spending as to not strain the General Fund; the City has a lot going on and just go through the numbers before making any big decisions. Much of the activities in the General Fund are not big money makers. Baumann suggested having a discussion regarding transferring from additional funds to replenish some of that General Fund. Savings accounts can be helpful when budgeting for larger items. The single audit is required to ensure the City is in compliance from receiving Federal money for the Well Field and Transmission Main Water project as well as award money for the Aqua Center Bathhouse. The single audit will need to continue to be done as the City will be receiving federal dollars for at least a few years. Blome reiterated Bauman's comments and will work with the City on tightening up some of the areas in the Governmental Funds. Additional discussion was had on savings accounts, sales tax and when bonds are scheduled to be paid off. Council Member Wesley Halvorsen moved to approve the 2021 Audit, Orv Gigstad seconded.
