HEARING OF THOSE PRESENT - No one present.

SHERIFF REPORT – Otoe County Sheriff Caudill present; the report has been distributed. There were 46 calls for service during the month of March, 37 were reportable. The department assisted a task force with an arrest of a fugitive from a different area. The majority of the incidents were traffic stops with 13 total. Caudill explained the department wrapped up the vandalism case at the St. Paulinus Catholic Church very quickly. With summer months approaching and school dismissing soon, the department will be ramping up coverage.

LIBRARY REPORT – Director Melissa Juilfs present. Juilfs reported it has been an eventful first few months at the Syracuse Public Library. She expresses she's still learning but gaining traction in many areas. Juilfs reported on unofficial programming, needs moving forward and updating our technology systems, the roles of the board. Circulation numbers is up, computer usage is up but the Library is definitely growing. Lots of new books are becoming available as well as activities and programs.

PARKS & REC REPORT – Director Sonni Graves not present. Mayor Dettmer led the discussion for request for Keno Funds; Boy Scout Kaden Knake present to explain. Knake is working towards his Eagle Scout project and would like to replace the flagpole holders at the Park Hill Cemetery. This will enable the areas to be located more efficiently as the concrete is beneath the surface and covered with grass and dirt; many of the caps get damaged by mowers. Knake is asking for \$150.00 in Keno Funds; the remaining \$600.00 has been donated to Knake towards his project. Council Member Jerry Werner moved to approve the request for funds, Orv Gigstad seconded. Roll Call: Yeas: Nate Patton, Wesley Halvorsen, Jerry Werner, Orv Gigstad. Nays: none.

PUBLIC WORKS – Superintendent Jeff Vogt not present. Adams explained the amendment is for additional water main improvements to utilize additional SRF funds. Three proposed projects include replacement on Mohawk, the north loop up to the hospital and a few additional blocks on Park Street. If additional funds are left, Jeff Vogt and Dane Simonsen have discussed a few smaller projects. Adams explained there is an existing utility easement up by the hospital and may be a need for some temporary easements. JEO will prepare any documentation needed for any temporary easements. RESCUE REPORT - Chief Tim Wilson present. Mayor Dettmer led the discussion and update of billing services. Wilson explained he and Jerry Stilmock have been in discussions with Quick Med Claims, the squad's current billing service. Quick Med Claims said they are working to correct the issues and that it was an internal issue. Wilson has negotiated a lower rate and answering any questions they have regarding any of the squad's paperwork; some of these questions go back to 2020 and Wilson was not notified of any issues or questions Quick Med Claims say they had. Wilson and Stilmock have another meeting scheduled with them. Revenue from the billings has increased since Wilson reached out to them. Wilson requested a quote from One Billing Solutions; Wilson has worked with the rep from One Billing Solutions as she was with EMS Billing prior to them being bought out by Quick Med Claims. Software is available to learn how to do the billing as well as some training; Nebraska City has moved their billing in-house. It may be possible to have a contract with Nebraska City to have their services provided to Syracuse Rescue as well. Stilmock explained what the current contract says. Wilson would not be offended if the City Council recommends the SRS move another direction. He explained the process to change is not an easy one though. Wilson explained bringing the billing services in house is a lot of work and their time would need to be compensated from the Ambulance budget, which is currently not in the budget. Protection would be provided if the SRS continues to go with a third-party vendor plus their expertise.

OLD BUSINESS – Mayor Dettmer led the discussion and resolution to approve Subdivision Agreement and Escrow Agreement between City of Syracuse and Zahn Meadows, LLC, authorizing Mayor's signature. The item is tabled until a future City Council meeting.
